	and central nervous system depression, while delayed effects may include liver, kidney, or nervous system damage from prolonged or repeated exposure.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

5.1 Extinguishing media:	Water, Carbon dioxide dry chemical, Alcohol-resistant foam.
