<b>Inhalation:</b>	can cause respiratory irritation, dizziness, headache, nausea, and in high concentrations, central nervous system depression.

<b>Skin Contact:</b>	can cause irritation, redness, dryness, and possible dermatitis with prolonged or repeated exposure.
