2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, wheezing, and long-term exposure may lead to asthma or lung sensitization.

Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, systemic toxicity affecting the kidneys and liver.
Skin Contact:	can cause irritation, redness, itching, and allergic dermatitis, especially in individuals sensitive to nickel.
Eye contact:	can cause irritation, redness, watering, and possible damage to the cornea with prolonged exposure.
Chronic Exposure:	can lead to skin sensitization, allergic dermatitis, respiratory issues, lung damage, and an increased risk of cancer, particularly nasal and lung cancer.
Aggravation of pre-existing conditions:	can worsen pre-existing respiratory conditions (like asthma), skin disorders (such as eczema), and kidney or liver problems.

General information:
