2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and long-term exposure may lead to lung damage or sensitization.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, systemic toxicity affecting the kidneys and cardiovascular system.
Skin Contact:	can cause irritation, redness, itching, and in some cases allergic dermatitis or sensitization.
Eye contact:	can cause severe irritation, redness, tearing, pain, and potential damage to the cornea if not promptly rinsed
Chronic Exposure:	can cause skin sensitization, respiratory issues, lung fibrosis, and an increased risk of cancer, particularly nasal and lung cancers.

General information:

4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects include acute respiratory irritation, coughing, nausea, vomiting, skin and eye irritation, and delayed effects such as sensitization, lung damage, and increased cancer risk.
