2.3 Other hazards:	
Inhalation:	can cause headache, dizziness, nausea, shortness of breath, cyanosis, and in severe cases, methemoglobinemia, which reduces the blood's oxygen-carrying capacity.
Ingestion:	can cause abdominal pain, nausea, vomiting, dizziness, weakness, cyanosis, and potentially life-threatening methemoglobinemia.
Skin Contact:	can cause irritation, redness, and absorption through the skin, potentially leading to systemic toxicity such as headache, dizziness, and methemoglobinemia.
Eye contact:	can cause irritation, redness, pain, and watering, and may lead to more severe damage if not promptly washed out.

Chronic Exposure:	can lead to liver and kidney damage, anemia due to prolonged methemoglobinemia, nervous system effects, and potential reproductive toxicity.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory, cardiovascular, liver, or blood disorders, and may worsen conditions like anemia or methemoglobinemia.
