Chronic Exposure:	may cause skin dryness or dermatitis, respiratory irritation, and potential neurological effects such as headaches, dizziness, or nerve damage with prolonged inhalation.

General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
