4.2 Most important symptoms and effects, both acute and delayed:	Phosphorus pentachloride causes immediate corrosive irritation and burns to the eyes, skin, and respiratory tract, with delayed effects that may include persistent respiratory damage and tissue injury.

5.1 Extinguishing media:	Carbon dioxide dry chemical Do not use water
