2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, and shortness of breath.
Ingestion:	large amounts can cause nausea, vomiting, abdominal pain, and potentially dangerous high blood potassium (hyperkalemia).
Skin Contact:	can cause mild irritation, redness, or dryness.
Eye contact:	can cause irritation, redness, and watering.
Chronic Exposure:	may cause prolonged irritation of the skin, eyes, or respiratory tract, and repeated ingestion could lead to electrolyte imbalances, especially elevated potassium levels (hyperkalemia).
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions (like asthma), kidney problems, or heart conditions due to its potential to cause irritation and alter potassium levels.

4.1 Description of first aid measures	
General information:	

After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	Remove contaminated clothing immediately. Wash with plenty of water. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important acute and delayed effects include irritation of the eyes, skin, and respiratory tract, gastrointestinal upset if ingested, and with repeated or high exposure, potentially dangerous electrolyte imbalances such as elevated blood potassium levels.
