2.3 Other hazards:	
Inhalation:	may cause severe irritation or burns to the respiratory tract, leading to coughing, shortness of breath, and potentially life-threatening lung damage due to hydrogen fluoride release.
Ingestion:	may cause severe burns to the mouth, throat, and stomach, with systemic toxicity from fluoride ions that can lead to hypocalcemia and potentially fatal effects.
Skin Contact:	may cause severe chemical burns and deep tissue damage, with fluoride absorption potentially leading to serious systemic toxicity.
Eye contact:	can cause severe irritation, painful burns, corneal damage, and may result in permanent vision loss.
Chronic Exposure:	may lead to fluoride accumulation, causing bone and tooth damage (fluorosis), kidney impairment, and long-term tissue irritation.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory, kidney, or skin conditions, and can worsen heart problems due to systemic fluoride toxicity.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause severe burns, pain, coughing, difficulty breathing, nausea, and hypocalcemia, while delayed effects may include tissue damage, bone and tooth fluorosis, and kidney or heart complications.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.
