2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, causing coughing, shortness of breath, and, in high or prolonged exposure, central nervous system effects like dizziness or headache.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in large amounts may lead to neurological effects such as confusion, dizziness, or even bromism.
Skin Contact:	may cause mild irritation, redness, or dryness, especially after prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, and watering, and prolonged exposure may lead to more severe discomfort.
Chronic Exposure:	can lead to bromism, characterized by neurological symptoms such as headache, fatigue, memory loss, tremors, skin rashes, and in severe cases, psychiatric disturbances.
Aggravation of pre-existing conditions:	may aggravate pre-existing kidney, liver, or neurological conditions, and can worsen respiratory or skin sensitivities in susceptible individuals.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause nausea, vomiting, diarrhea, respiratory irritation, and dizziness, while delayed or chronic effects may include neurological symptoms, skin rashes, fatigue, and bromism.
