2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract and may cause headache, dizziness, or shortness of breath due to reduced oxygen delivery in the blood.
Ingestion:	can cause nausea, vomiting, abdominal pain, and potentially serious methemoglobinemia, reducing the blood's ability to carry oxygen.
Skin Contact:	may cause irritation, redness, or dryness, especially with prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, tearing, and pain, and may result in temporary eye injury if not promptly rinsed.
Chronic Exposure:	may lead to ongoing blood effects such as methemoglobinemia, along with persistent respiratory or skin irritation from repeated contact.
Aggravation of pre-existing conditions:	may occur in individuals with blood disorders, respiratory illnesses, or skin sensitivities, which can be worsened by exposure to potassium nitrite.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	Remove contaminated clothing immediately. Wash with plenty of water. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important acute and delayed effects are oxygen deprivation due to methemoglobinemia—causing headache, dizziness, cyanosis, and shortness of breath—along with gastrointestinal distress and irritation of the skin, eyes, and respiratory tract.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.
