2.3 Other hazards:	
Inhalation:	can cause irritation of the respiratory tract, coughing, shortness of breath, and in severe cases, pulmonary edema.

Skin Contact:	can cause irritation, redness, and, in severe cases, chemical burns.
Eye contact:	can cause severe irritation, redness, pain, tearing, and possible corneal damage.
Chronic Exposure:	can lead to fluoride accumulation, dental and skeletal fluorosis, kidney damage, and prolonged respiratory or skin irritation.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions (like asthma), kidney disorders, and skin sensitivities, and may worsen dental or skeletal issues related to fluorid

General information:
