2.3 Other hazards:	
Inhalation:	may cause respiratory irritation, especially in high concentrations or prolonged exposure.
Ingestion:	large amounts may cause gastrointestinal irritation, nausea, or diarrhea.
Skin Contact:	may cause mild irritation, especially with prolonged or repeated exposure, leading to redness, dryness, or itching.
Eye contact:	may cause irritation, leading to redness, watering, or a stinging sensation.
Chronic Exposure:	Chronic exposure to propylene glycol, especially through prolonged skin contact or inhalation of vapors in high concentrations, may lead to skin dryness, irritation, or potential respiratory issues, although it is generally considered to have low toxicity with long-term exposure.
Aggravation of pre-existing conditions:	may aggravate pre-existing conditions such as skin conditions (e.g., eczema or dermatitis) or respiratory issues (e.g., asthma) due to its potential to cause irritation or allergic reactions.

SECTION 4: First aid measures

4.1 Description of first aid measures	
General information:	

After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	Remove contaminated clothing immediately. Wash with plenty of water. Consult a physician.
After eye contact:	Immediately flush eyes with plenty of water for at least 15 minutes. consult a physician.
After swallowing:	Rinse mouth with water. Immediately after ingestion. If conscious, make victim drink two glasses at most immediately. Never give anything by mouth to an unconscious person. Do not induce vomiting. Consult a physician.
4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects of propylene glycol include acute skin and eye irritation, respiratory discomfort, and gastrointestinal upset from ingestion, with delayed effects potentially involving prolonged skin dryness or respiratory issues from chronic exposure.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

SECTION 5: Firefighting measures

5.1 Extinguishing media:	Carbon dioxide. Water spray. Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Carbon oxides.
5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapours accumulating to form explosive concentrations. Avoid dust accumulation. Seek medical attention.
6.2 Environmental precautions:	Do not enter this chemical into drains.
6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g.: sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers. Spill must not return in its original container. Clean contaminated surfaces with an excess of water. Wash clothing and equipment after handling.

Store away from incompatible materials and foodstuff containers. Protect containers against physical damage and check regularly for leaks. Store in a dry and dark area.
