4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute and delayed exposure can cause severe skin and eye irritation or burns, respiratory distress, coughing, nausea, vomiting, and dermatitis with possible long-term sensitization.
