2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, cause coughing, shortness of breath, and in high exposure, may lead to lung damage or systemic selenium toxicity.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, acute selenium poisoning, which may affect the liver, kidneys, and nervous system.
Skin Contact:	can cause irritation, redness, and in prolonged exposure, chemical burns or dermatitis.
Eye contact:	can cause severe irritation, redness, tearing, and possible corneal damage.
Chronic Exposure:	Chronic exposure can lead to selenosis, causing symptoms such as hair and nail loss or brittleness, garlic-like odor on the breath, fatigue, irritability, and neurological disturbances.

Aggravation of pre-existing conditions:	may worsen pre-existing respiratory conditions (like asthma or bronchitis) and can aggravate skin disorders or other sensitivities to chemical irritants.
