2.3 Other hazards:	
Inhalation:	may irritate the respiratory tract and, with prolonged or repeated exposure, could lead to argyria or other silver-related health effects.
Ingestion:	may cause gastrointestinal irritation and, with significant or prolonged exposure, could result in silver accumulation in the body leading to argyria.
Skin Contact:	may cause mild irritation and, with prolonged or repeated exposure, can lead to skin discoloration due to silver accumulation.
Eye contact:	may cause irritation, redness, and discomfort, especially if particles become lodged in the eye.
Chronic Exposure:	may result in argyria (a permanent bluish-gray discoloration of the skin and eyes) and potential damage to internal organs due to silver accumulation.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory disorders, skin conditions, or eye sensitivities, particularly in individuals with asthma or chronic dermatitis.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
