2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract and may cause coughing, shortness of breath, or long-term lung effects with prolonged exposure.
Ingestion:	can cause gastrointestinal irritation, nausea, vomiting, diarrhea, and may lead to systemic silver accumulation (argyria) with chronic exposure.
Skin Contact:	can cause irritation, redness, and in some cases allergic reactions or prolonged staining of the skin.
Eye contact:	can cause irritation, redness, pain, and potential temporary damage to the cornea.
Chronic Exposure:	can lead to argyria (a permanent bluish-gray discoloration of the skin and mucous membranes), respiratory issues, and potential organ accumulation of silver.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma or bronchitis) and skin disorders, increasing irritation or sensitivity.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
