General information:

4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects of sodium acetate anhydrous include irritation of the eyes, skin, and respiratory tract, nausea or vomiting if ingested, and, in sensitive individuals, delayed aggravation of pre-existing respiratory or skin conditions.
