2.3 Other hazards:	
Inhalation:	can cause severe irritation and burns to the respiratory tract, coughing and shortness of breath, and may lead to pulmonary edema and systemic fluoride toxicity.
Ingestion:	can cause severe burns to the mouth, throat, and stomach, leading to intense pain, vomiting, diarrhea, and potentially life-threatening systemic fluoride toxicity affecting the heart and calcium levels.
Skin Contact:	can cause severe chemical burns, pain, and tissue damage, with fluoride absorption potentially leading to systemic toxicity.
Eye contact:	can cause severe irritation and chemical burns, potentially resulting in corneal damage and permanent vision loss.
Chronic Exposure:	may result in skeletal fluorosis, dental fluorosis, and long-term damage to bones, teeth, and the kidneys due to cumulative fluoride toxicity.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory disorders (such as asthma or bronchitis), skin conditions, eye disorders, and kidney disease due to its corrosive and systemic fluoride effects.

4.2 Most important symptoms and effects, both acute and delayed:	Most important symptoms and effects include severe corrosive burns to the skin, eyes, and mucous membranes; respiratory irritation or pulmonary edema; and delayed systemic fluoride toxicity causing hypocalcemia, cardiac arrhythmias, and potential organ damage.
