Skin Contact:	can cause irritation, redness, and possible rashes, especially with prolonged or repeated exposure.

Chronic Exposure:	can lead to skin rashes, neurological symptoms (such as headache, confusion, or tremors), and bromism, a condition caused by bromide accumulation in the body.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects include acute irritation of the eyes, skin, and respiratory tract, gastrointestinal upset, dizziness, and in delayed or prolonged exposure, neurological effects such as confusion, tremors, and bromism.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.
