2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, cause coughing, shortness of breath, and prolonged exposure may lead to lung damage or fluoride-related toxicity.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, fluoride poisoning affecting bones, teeth, and internal organs.
Skin Contact:	can cause irritation, redness, and dryness, and prolonged or repeated exposure may lead to dermatitis.
Eye contact:	can cause irritation, redness, and a stinging or burning sensation.
Chronic Exposure:	can lead to fluoride accumulation, causing skeletal fluorosis, dental fluorosis, kidney damage, respiratory issues, and long-term bone and joint problems.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions (like asthma or chronic bronchitis), skin disorders (such as eczema), and kidney or bone-related conditions due to fluoride accumulation.
