2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, causing coughing, shortness of breath, and in severe cases, pulmonary edema.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in high doses, severe systemic toxicity affecting the heart, nerves, and potentially leading to death.
Skin Contact:	can cause irritation, redness, and, with prolonged exposure, chemical burns.
Eye contact:	can cause severe irritation, redness, pain, and possible corneal damage.
Chronic Exposure:	can lead to dental and skeletal fluorosis, kidney damage, and potential effects on the nervous system.
Aggravation of pre-existing conditions:	can aggravate pre-existing kidney disease, skeletal disorders, and respiratory conditions, and may worsen dental sensitivity or existing fluoride-related health issues.

General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute and delayed exposure can cause respiratory irritation, coughing, nausea, vomiting, abdominal pain, skin and eye irritation, and, in severe cases, potential organ toxicity.
