<p>Inhalation:</p>	<p>can cause respiratory irritation, leading to symptoms such as coughing, shortness of breath, and difficulty breathing.</p>

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Immediately administer a corticosteroid from a controlled/metered dose inhaler. Consult a physician.
After skin contact:	Remove contaminated clothing. Wash with soap and water. Consult a physician.

After eye contact:	Immediately flush eyes with plenty of water for at least 15 minutes. consult a physician.
After swallowing:	Rinse mouth with water. Immediately after ingestion. Never give anything by mouth to an unconscious person. Do not induce vomiting. Consult a physician.
4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure include acute toxicity (e.g., nausea, vomiting, dizziness, and headache) after ingestion, respiratory irritation after inhalation, skin and eye irritation, and delayed effects such as methemoglobinemia, which impairs oxygen delivery to tissues.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

SECTION 5: Firefighting measures

5.1 Extinguishing media:	Carbon dioxide. Water spray. Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Special hazards arising include its potential to release toxic nitrogen oxides (NOx) when heated, its oxidizing nature that can intensify fires, and the formation of carcinogenic nitrosamines when it reacts with amines, especially in food under high temperatures.
5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation.
